# Learning and Teaching Strategies:

Drawing primarily upon constructivist and dialogic (socioculturalist) teaching methodologies, this module will develop knowledge of social work methods utilising principles of differentiation and will begin with basic comprehension and application, to analysis and evaluation. A range of small and large group strategies will be employed to encourage peer learning and feedback, as well as visual, didactic and auditory (transmission) teaching methodologies to ensure a range of learning preferences are duly considered. VLE will also support and build on learning in-between lecture times.

### Syllabus outline:

**Semester One:** What are methods and models of intervention? Transactional Analysis, Crisis Intervention. Task Centred, Systems Theory, Cognitive Behaviourism, Motivational Interviewing, Person Centred Approaches, Feminism and Feminist Group work, Solution Focused Theory, Narrative Approaches, Radical structuralism (Marxism) Models and Methods and anti-oppressive and anti-discriminatory practice.

**Semester two**: International and European perspectives of social work methods, how methods link to wider theoretical paradigms in social work theory. How does the development of case work ideology in a social work context influence the deployment of certain methods over others?
