#### Learning and Teaching Strategies:

Students will be required to submit a title, plan and reading list in relation to their intentions and this will be discussed by the criminal justice team before the student proceeds with their study and signs a learning agreement. Thereafter, the negotiated learning module will be supported by individual tutorials with an identified member of staff with relevant expertise in the specialist area identified. Students will be encouraged to work independently and to utilise agency contacts where appropriate to identify an area for study. Support will be provided in weekly online synchronous meetings or face to face meetings depending on the preferences of the student concerned.
