#### Module aims

This module aims to build understanding of the nature of registration for social workers within current frameworks of regulation, exploring the dynamics of practice and the importance of personal development and growth'

Utilising the knowledge base of theory and understanding the importance of research, students will learn about evidence based practice and how this links to everyday practice. The students will learn about the importance of reflection and how understanding different perspectives and challenging assumptions is vital to a well-rounded practice. Students will consider the use of technology in the provision and receipt of services, a method by which to engage individuals, families and communities and a tool for professional practice. The students will consider the issues that are present in contemporary social work; challenges, opportunities, pressures, strains and rewards – all of which will impact differently on the students existing resources and strengths, and highlighting areas where development is needed.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Explain the implications of social work being a regulated profession for students
2	Describe and utilise models of reflection
3	Explain and apply the interrelated knowledge, skill and value base of social work
4	Utilise technology to demonstrate an ability to use data and present information in a professional manner
5	Identify the benefits and challenges of using technology to promote participation and inclusion
6	Demonstrate accountability for personal and professional development through engagement in the module content.

#### Assessment

Indicative Assessment Tasks:

Assignment 1: Coursework – collection of four reflective logs (total equivalent of 2000 words) using a chosen form of digital media (e.g. Word, Powerpoint, blog/vlog etc.). Each reflective log to cover a single taught session (from any module), and

outline key messages, challenges, learning and intended development as a result of the session.
