Module aims

This module is designed to create an opportunity for critical analysis of two dominant themes in contemporary social work practice: early intervention through promotion of wellbeing/coproduction and safeguarding. Recent legislative developments are moving social work practice towards integrated and whole family interventions. This module uses emerging evidence-based practice to examine and critically analyse how the professional tensions created by these two themes can be managed to promote wellbeing.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Critically analyse factors which influence safeguarding policy and practice for social work in Wales
2	Critically analyse the sources of evidence that underpin safeguarding practice in Wales
3	Critically examine the key processes and methods used in safeguarding agencies for the protection of both children and adults, and the organisations tensions that exist.
4	Critically analyse the interpersonal and inter-professional tensions and conflicts that can arise between the agendas of early intervention and safeguarding
5	Demonstrate accountability through module engagement

Learning and Teaching Strategies

The module will use a variety of methods for teaching & learning, including lectures, group work, discussion, use of VLE for discussions, links to resources, lecture notes, etc. Service user and carer participation will be a feature, including use of materials (e.g. written accounts, etc.) and visiting speakers. Practice examples will be used in the form of case studies, drawing on students' own experience and talks/workshops delivered by social workers and social care practitioners.

Indicative Syllabus Outline

In semester 1, the module will cover the following areas prior to students commencing their 100-day final practice learning opportunity:

- The historical tensions between early intervention and the development of modern safeguarding practice.
- Historical context of modern perceptions of safeguarding.
- Historical context of child protection and adult protection as separate social work tasks and current processes towards an integrated whole family approach in Wales.
- The evidence base for the methods used in social work practice for assessment, planning and intervention of safeguarding.
- Critical analysis of safeguarding methods and theoretical underpinnings.
- The pressures of law, media, public expectation, and organisational change and how these create conflicts for social work practice.
- Integrating social work values, ethics, participation and co-production into safeguarding practice in Wales and some of the tensions that exist.
