Students will develop a critical awareness of the complexities that animal welfare organisations face in their challenge to improve the wellbeing of animals in the global environment.

Students will have the opportunity to appraise and apply critical thinking skills to a diverse range of animal welfare scenarios and interventions.

The portfolio will include a systematic assessment of a variety of rehabilitation techniques and strategies.
