### Module aims

The overall aim of this module is to introduce students to a structured approach to support individuals as they and their organisations traverse the current challenges of an evolving workplace where the work patterns of the pandemic is driving a more flexible approach to work. This includes providing students with a practical toolkit and a range of techniques that can be deployed to support HR efforts in an organisational setting. It also includes an understanding of the tools and techniques required to respond more efficiently to an evolving workplace.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Describe what the HR challenges are and exploring some of the HR management practices that are beginning to emerge
2	Demonstrate a knowledge and skills that will help HR to plan positively for post-crisis recovery.
3	Develop a range of tools and techniques required to respond more efficiently to an evolving workplace.
4	Evaluate the skills needed to recognise and manage the challenges to increase capacity to approach multiple HR challenges at once.

## Assessment

# Learning and Teaching Strategies

This module will be delivered entirely online and the learning and teaching strategies will be accessible and wide-ranging in order to cater for a diverse audience. It is anticipated that content will take the form of recorded lectures, supporting signposts to learning materials such as links to videos, a moodle book if appropriate and further reading, asynchronous tutorials via discussion forums and live dialogic forums to stimulate thinking. Students will be expected to engage with all content.

The delivery for the four week short course will include:

- 1 x recorded lecture per week
- Supporting signposts to learning material on Moodle, such as links to videos (e.g. TED talks),
- A study guide if appropriate and further reading
- Material to support the delivery of 3 x Asynchronous tutorials
- Delivery of 1 x 2hr Dialogic forums
