Module aims

The overall aim of this module is to introduce students to the theory and work practices associated with growing and operating business in a way that improves the social, economic, environmental, and cultural well-being of the nation. This includes detailing the ways that organisations should think more about the long-term, work better with people and communities and with other organisations to prevent problems to take a more joined up approach that will help to create a nation we all want to live in, now and in the future.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Define sustainable business practice.
2	Provide examples of actions and behaviours associated with sustainable business practice, aligned with each of the '7 Well-being Goals' of the 'Well-being of Future Generations (Wales) Act (2015).
3	Describe the business models, benchmarks and certifications associated with sustainable business practice, and the advantages and disadvantages associated with each.
4	Identify clear actions to advance sustainable business practice through their own work or study.

Learning and Teaching Strategies

This module will be delivered entirely online and the learning and teaching strategies will be accessible and wide-ranging in order to cater for a diverse audience. It is anticipated that content will take the form of recorded lectures, podcasts, supporting signposts to learning materials such as links to videos, a study guide if appropriate and further reading, asynchronous tutorials via discussion forums and live dialogic forums to stimulate thinking. Students will be expected to engage with all content.

The delivery for the eight week short course will include:

- 6 x recorded lectures
- A study guide (Moodle Book) if appropriate and further reading
- Material to support the delivery of 8 x Asynchronous tutorials
- Delivery of 2 x 2hr Dialogic forums
- 8 x 30 minute Podcasts
- Supporting signposts to learning material on Moodle, such as links to videos (e.g. TED talks),
- Signposting to in-depth Glyndwr Courses on key elements e.g. renewables
