## Module aims

---

This module will develop aspiring healthcare service manager in the development of their management skills, knowledge and understanding in both operational and strategic settings through the critical appraisal of theories and approaches. It will identify the challenges facing global health services, and enable the development of critical management skills required within this service.

4	Using available resources, evidence, academic theory and research, and applying problem solving techniques and decision-making skills, present a reasoned argument to justify the managements skills needed to ensure the effective operation of global health services.
5	Demonstrate independent learning ability and self-reflection of one's own research journey and findings as well as one's approach to communication and collaboration with others when identifying solutions.

## Learning and Teaching Strategies

The learning and teaching strategy will consist of formal lectures to present theory, principles and practices which will form the foundation of the learning outcomes. Lectures will be structured to encourage individual and group activities using real world case studies and live business examples enabling students to develop their collaborative, decision making, judging and evaluating skills, as well as key transferable employability skills. In addition, students will be encouraged to undertake self-directed study and further research on their chosen area of study, as well as related topics, to acquire additional perspectives which will provide them with a greater understanding of the business topics within organisations and the wider environment.
