#### Module aims

This module aims to introduce students to the concept of social action and the work of civil society in supporting children and families within their communities. It will explore the role of volunteering and the benefits this may bring to the student, the third sector organisation and the communities in which the volunteering takes place. This module will introduce students to a range of voluntary organisations by exploring their purpose and the activities they provide.

### **Module Learning Outcomes -** at the end of this module, students will be able to:

1	Examine the role of civil society in the lives of children, families and community.
2	Explore the concept of social action and the benefits which may arise for the volunteer, the third sector organisation and the recipients of the support.
3	Analyse the role of informal learning in the lives of children to support developmental and educational aims.
4	Evaluate the purpose and range of activity offered by third sector organisations working with children and families.

#### **Assessment**

**Indicative Assessment Tasks:** 

- 1. Presentation Students are required to deliver a presentation covering the purpose of civil society, the benefits of social action and the role of informal education to children and families. (Presentation slides + 10 minute presentation)
- 2. Coursework Students are to prepare a poster promoting the aims and activities of a voluntary organisation of their choice. (1 side A1)
