Module aims

This module will discuss a range of contemporary public health issues at local, national and international levels. It will cover the emergence and development of selected issues, their epidemiology, and the implications for policy makers and practitioners.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Identify contemporary public health issues and discuss their epidemiology.
2	Explain how public health issues emerge and develop in social, cultural, economic and environmental contexts.
3	Discuss the implications public health issues have for policy makers and practitioners.
4	Critically analyse a public health issue of their choice.
5	Evidence their ability to work in a pair to produce a shared outcome.

Assessment

Indicative Assessment Tasks:

This section outlines the type of assessment task the student will be expected to complete as part of the module. More details will be made available in the relevant academic year module handbook.

Assessment 1

In a pair, students will be required to produce and deliver a 15-minute presentation that critically analyses a contemporary public health issue of their choice. The analysis should include a discussion of the nature and epidemiology of the issue, as well as the implications for policy makers and practitioners. The same mark will be awarded to both students.

Assessment 2



Students will be required to submit an appendices document that evidences their individual contribution to the presentation and how they attempted to work effectively with their partner. The appendices document may include a 'work contract' agreed at the start of the process, the agendas and minutes from meetings, and a 500-word reflection. A different mark may be awarded for each student depending upon the evidence submitted in this document.
