Module Aims:

The aims of this module are to further build on the skills of occupational therapy assessment and develop skills of planning within the practice education setting. This will provide the opportunity to integrate theory and practice. It will give the student the opportunity to continue to develop a range of skills including communication, organisation and management, reflective, professional and inter-professional abilities.

Learning and Teaching Strategies:

Students will use self directed study and independent learning throughout the Planning placement. They will have the opportunity to carry out experiential learning in the setting, utilising modelling, observation and practice, guided by educator feedback, further developing their skills from assessment placement. The practice education setting will support student centred learning based around the development of an individual learning contract. Other learning opportunities will include reflection, tutorials, in-service training, supervision and work based investigation.

Syllabus outline:

Students will be allocated a 6 week full time placement in a setting with a placement educator.

The focus of this placement will be on the skills of Planning and provide the student with the opportunity to further develop skills of assessment. Opportunities include the use of different types of assessment e.g. standardised and non standardised, subjective, objective along with safe and appropriate ways of using assessment information in order to plan for and with service users in diverse setting, ways of reporting, recording and communicating occupational therapy plans to other, ways of managing self whilst planning and the role of others (service users, carers, other professionals) in planning.

The detailed outcomes reflecting the placement area (based on the general outcomes highlighted above) are negotiated individually for each student and are recorded in a learning contract.
