## Module aims

Further exploring knowledge and research to inform the assessment and management of service users and formulate the most appropriate holistic treatment plans for a variety of medical, traumatic and well-being conditions dependant on sound decision making and latest evidence-based practice.

## Module Learning Outcomes - at the end of this module, students will be able to:

1	Critically analyse theories of decision making to reduce risk and improve outcomes for service users
2	Appraise current and new assessment, treatment, and management concepts in emergency and urgent care
3	Evaluate the benefits of referrals, alternative management, and collaborative practice in emergency and urgent care
4	Examine the effectiveness of own and wider paramedic practice based on current evidence and guidance

#### **Assessment**

Indicative Assessment Tasks:

This section outlines the type of assessment task the student will be expected to complete as part of the module. More details will be made available in the relevant academic year module handbook.

#### **Formative Assessment:**

The module's formative assessment and feedback opportunities will be outlined in the assessment strategy in the module handbook. Students will undertake formative assessments within the first four to six weeks of the module.

Student's learning will be observed during the teaching of the module with ongoing feedback during topical group discussions to improve their understanding. For the assessment there will be assignment workshops to develop the skills needed for the assessment and an opportunity to submit an assignment plan to the module leader for review and feedback through tutorials. There will be peer groupwork and presentations within the taught sessions to help prepare you for the summative assessment.

#### **Summative Assessment:**

The one summative assessment for this module is a 10-minute presentation on a contemporary assessment or management topic related to paramedic practice. For this assignment, in discussion with the module leader, you will select a topic that is new or innovative that contributes to the care of service users in the pre-hospital setting. Examples include new diagnostic equipment or techniques, introduction of new medications or interventions and new decision tools or referral pathways. You will need to thoroughly research the topic and appraise the evidence along with the benefits and justification then

reveal your findings in a concise presentation. Developing good presentation skills will help you to inform and persuade an audience and can also help you demonstrate your communication and leadership skills.

This is a core module and therefore an overall pass of the module is required for progression within the course. You will need to pass the assessment with a mark of 40% or above to receive a passing grade for the module. The assignment has a 100% weighting and therefore the mark you achieve will be the overall grade for the module.

If you are unsuccessful at achieving a passing grade on your first attempt the standard resit opportunities are granted. After reassessment the overall grade for any resit assessments will be capped at 40% which will then be your overall grade for the module.

## **Learning and Teaching Strategies**

During previous modules you will have learnt and practised the assessment and management skills within the scope of practice of a current-day paramedic. Within this module we will explore and evaluate the continual development of new contemporary and innovative assessment and management ideas that are being researched and introduced into paramedic practice.

The topics discussed will be dependent on the most up-to-date research and issues and, within the taught sessions we will evaluate the evidence and the potential benefits to service users and the profession. Practical session will be used to test some of these new ideas so that you can develop an appreciation of their impact on practice.

Incorporated into this module is additional alternative practice placement time which will be spent with different healthcare professionals in other health and social care settings. This is to provide a familiarisation of referrals, alternative management, and collaborative practice and their connection with our own profession.

A blended learning approach, a balance between classroom elements and digitally enabled (online) activity, will be used during the delivery of this module. Face-to-face sessions and online educational materials, using the University's Virtual Learning Environment (VLE) – Moodle, will be combined to allow more flexibility over the time, place, and pace of your study.

There will be directed pre-session materials that will prepare you for the synchronous learning that takes place in real time in the form of seminars or workshops. Post-session learning materials, such as additional reading, worksheets, and quizzes, will be provided to

amalgamate and further your understanding of the topics covered. Learners have a responsibility to manage and engage with the asynchronous learning course materials (video clips, recorded lectures, forums, readings, and quizzes) available on Moodle.

Face-to-face sessions – or synchronous learning - will allow students to develop their understanding of a topic through further discussions and tutor-led problem-based tasks and other learning activities. Teaching will be delivered through seminar style sessions incorporating group and project work.
