Module Aims

This module aims to:

- Introduce students to the main political, social, economic and religious developments in Wales during the nineteenth and early twentieth centuries
- Examine the way in which national consciousness and national divisions affected Welsh society during this period

Intended Learning Outcomes:

At the end of this module, students will be able to:

- 1. Identify and evaluate the main social and economic patterns and processes at work in Wales during the period (KS1, KS6)
- 2. Analyse the different methods of protest practised in Wales and consider the implications of this behaviour (KS1, KS6)
- 3. Critique the impact of Nonconformity on Wales (KS1)
- 4. Explain in depth the way in which the political culture of Wales developed during the nineteenth century (KS1, KS7)
- 5. Analyse primary source material to reach conclusions about the image and reality of life in Wales during the period (KS1, KS3, KS4, KS6, KS10)

Assessment:

Assessment One is a case study which requires a detailed consideration of primary source material. This could range from a qualitative evaluation of visual/written works or a statistical analysis of documentation, eg. *Religious Census of 1851*, *Report on the State of Education* in 1847, contemporary newspapers or paintings of the industrial landscape

Assessment Two is a two hour unseen examination in which students are required to answer two questions on the main themes of the module.

Workshop sessions which concentrate on the analysis and discussion of primary source material will be integrated into the programme. Individual tutorials will be held to facilitate the Case Study work and to feedback on summative assessment.
