Module aims

This module aims to provide a comprehensive grounding to the professional and academic field of public health concepts and principles, and will introduce students to some of the issues that are presenting challenges to people's health and wellbeing in today's rapidly changing society. Globalisation, new technologies, and a growing and ageing population can be linked to issues such as climate change, air pollution, loneliness and the pandemic spread of viruses. These developments in society have implications for public health and the functioning of global health systems. The development of Public health policy will be explored from a global, international, national and local perspective. There will be particular focus on how policy affects and influences our day-to-day practice within the broad field of health, and the challenges this presents whilst maintaining an equitable, accessible and sustainable health service. Students will explore how a functioning and equitable health service can be maintained and sustained within the framework of critical understanding and appraisal of evidence based practice.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Demonstrate a critical understanding of multidisciplinary public health policy and strategy development
2	Realise and identify the social determinants of health and health inequalities, and apply this understanding to evaluating different approaches to improving health and reducing health inequalities
3	Critically explore core concepts and frameworks relevant to public health policy and population health
4	Identify how epidemiological approaches may help our understanding of global health challenges

Assessment

Indicative Assessment Tasks:

This section outlines the type of assessment task the student will be expected to complete as part of the module. More details will be made available in the relevant academic year module handbook.

The students must produce a critical study into a topical area of public health, outlining a relevant public health issue, how policies and actions have been developed around this issue, and the impact on their practice and/ or workplace. Students can select the method that best lends itself to their area of work specialism, and allows them to most effectively achieve the module learning outcomes. Students can choose from a) Essay (4,000 words) or b) Academic poster and a 15 minute presentation.

Learning and Teaching Strategies

This module will be delivered via a 'blended learning' approach. Directed study tasks, which may include activities such as recorded lectures, discussion forums, quizzes, case studies, group tasks, workbooks, key readings, reflective activities or other appropriate learning activity, will be made available on the Virtual Learning Environment on a weekly basis. The Flipped classroom approach will be utilised as far as possible to maximise the learning opportunities during synchronous sessions. Timetabled 'live' seminars/ sessions may be held (either in a physical classroom or via an online platform), in order to facilitate discussion and debate and support students to progress with their learning. These will be recorded when appropriate and made available on the VLE, encouraging deep learning by enabling content to be revisited and reflected on at a time suitable for the student.
