This module aims to enable students to build upon their knowledge of wounds in their clinical field and critically analyse the complexity of wound care management in today's modern healthcare system. This module will allow the students to develop critical thinking when considering wound care options in both the acute and community setting, enhancing their confidence in their ability to provide holistic, individualised care within their professional scope of practice.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Critically examine the nature of acute and chronic wounds within their specific clinical environment.
2	Plan effective wound assessment and management of simple and complex wounds in their specific clinical environment linked to contemporary evidence.
3	Critically analyse the associated symptom management strategies employed within their specific clinical environment.
4	Assess the safe-guarding and risks associated with wound care in their specific clinical environment linked to current and contemporary policy documents and public awareness.

Indicative Syllabus Outline

Anatomy of skin, pathophysiology of wounds, factors affecting wound healing, acute wounds, chronic wounds, pressure ulcers, dressing types (inc. use of dressings, contraindications and alternatives), wound assessment, challenging wounds and their management, decision- making, safe-guarding and risk management, associated symptoms of wounds (Inc. pain, psychological distress, altered body image and scar management), and burns.
